

or structure shall be erected, altered, placed or permitted to remain on any lot other than one detached single-family dwelling not to exceed two and one-half stories in height. However, notwithstanding any of the above, the Architectural Control Committee may in its sole discretion, designate certain portions of the Subdivision property, lots, or portions thereof, for recreational purposes shall not be a violation of these Protective Covenants.

2. DWELLING SIZE. The ground floor area of the main structure, exclusive of one-story, open porches and garages, shall be no less than 1400 square feet of heated floor space, nor less than 900 square feet of heated floor space for a dwelling of more than one story.

3. BUILDING LOCATION. No building shall be located on any lot nearer than 20 feet to the road lot line. No building shall be located nearer than 10 feet to any side lot line. No building shall be located on a lot nearer than 5 feet to the lake lot line. However, when more than one lot shall be used as a site for only one residence, the setback lines shall apply to the exterior side lot line, lake line and the road line of such consolidated lot. For the purpose of this covenant, eaves, steps, carports, and open porches shall be considered a part of the building.

4. EASEMENTS. A 5 foot wide easement is reserved along all lot lines for drainage and utility installations and maintenance, and no dwelling or building or structure shall be located, erected or constructed thereon, except that when more than one lot shall be used as a site for only one residence, the afore-said 5 foot easement shall apply only with respect to the exterior side and road and street lines of such consolidated lot.

5. NUISANCES. No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may become an annoyance or nuisance to the neighborhood. No business, trade, or commercial activity of any kind whatsoever shall be conducted in any building or on any portion of any lot. All lots shall be used exclusively for single-family residential

purposes and no other.

6. SIGNS. No signs of any kind shall be displayed to the public view on any lot except one professional sign of no more than one (1) square foot; however, one sign of not more than five (5) square feet advertising the property for sale or rent, or one sign of not more than five (5) square feet used by a builder to advertise the property during the construction and sale period shall be permitted.

7. LIVESTOCK AND POULTRY. No animal, livestock, or poultry of any kind shall be raised, bred, or kept on any lot, except that dogs, cats, or other household pets may be kept, provided that they are not kept, bred or maintained for any commercial purposes.

8. MINING AND DRILLING OPERATIONS. No quarrying or mining operations, no oil drilling, oil developments operations, or oil refinery operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, miner excavations, or shafts be permitted on any lot. No derrich or other structure designated for use in boring for oil or natural gas shall be erected, maintained, or permitted on any lot.

9. GARBAGE AND REFUSE. No lot shall be used or maintained as a dumping ground for rubbish. Abandoned automobiles or automobile parts shall not be permitted on the premises at any time. Trash, garbage, or other waste shall not be kept except in sanitary containers. All incinerators or other equipment for the storing or disposal of such materials shall be kept in a clean and sanitary condition.

10. SEWAGE DISPOSAL. No surface closet or outdoor privy facilities shall be permitted on any lot. No individual sewage disposal system shall be permitted on any lot unless such system is designed, located, and constructed in accordance with requirements, standards, and recommendations of the South Carolina Department of Public Health or the Anderson County Department of Public Health. Approval of such systems as installed shall be obtained from such authority.

11. FENCES, WALLS AND HEDGES. No fences, walls, or hedges shall be erected, located or planted along any lot line, and no tank for the storage of fuel upon the surface of the ground shall be erected, located or placed upon any lot, unless written approval for the establishment of same has been given by the Architectural Control Committee.

12. FURTHER SUBDIVISION OF LOTS. Lots 1, 8, 9, 10, 13, 15, 16, and 17 shall not be subdivided so as to create any additional lot. Lots 2, 3, 4, 5, 6, 7, 11, 12, 14, 18, 19, 20, 21, 22, 23, 24, may be subdivided no more than once to create one additional building lot; however, any additional building lot; or any additional building lots so created must be of sufficient size and area so as to comply with State and County zoning and health rules and regulations. This provision is not intended to prevent the cutting off of a small portion or portions of any lot for the purpose of conveying same to an adjoining lot owner, but under no circumstances may an owner of any lot or part thereof, except LAKE HARTWELL, INC., without the prior written consent of the Architectural Control Committee, build, lease, or permit the use of any part of said lot, as a way or entrances to any other property, whether within or without the subdivision property covered by these Protective Covenants and Restrictions. Other property as used herein shall also include, but not be limited to, property belonging to the United States Government, which is part of the Lake Hartwell Dam Reservoir projects.

13. TEMPORARY STRUCTURES. No structure of a temporary character, mobile home, tent, shack, camper, barn or other outbuilding shall be permitted on any lot at any time. Notwithstanding any of the above, a tent, travel trailer or camper may be located upon any lot for up to fourteen (14) days during any one year period, but for not more than fourteen (14) days.

14. ARCHITECTURAL CONTROL COMMITTEE. The architectural control committee is composed of Sidney L. Moore, B. E. Sims,

Warren A. Moore. A majority of the committee may designate a representative to act for it. In the event of death or resignation of any member of the committee, the remaining members shall have full authority to designate a successor.

Neither the members of the committee, nor its designated representative shall be entitled to any compensation for services performed pursuant to this covenant. At any time, the then record owners of a majority of the lots shall have the power through a duly recorded written instrument to change the membership of the committee or to withdraw from the committee or restore to it any of its power and duties.

15. TERM. These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty-five (25) years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive period of 10 years unless an instrument signed by a majority vote of the then owners of the lots has been recorded, agreeing to change said covenants in whole or in part. Ownership of 1 lot equals 1 vote, ownership of 2 lots equals 2 votes, etc. For clarification, if an individual/owns 5 lots he/it would be entitled to 5 votes. These covenants may be changed or modified at any time by an instrument given by a majority vote of the owners of lots at that time.

16. ENFORCEMENT. Enforcement shall be by the proceedings at law or in equity against any person or persons violating or attempting to violate any covenant either to restrain violation or to recover damages.

17. SEVERABILITY. Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
